



## THE WARREN SCHOOL PROVIDER ACCESS STATEMENT

### Introduction

This policy statement sets out The Warren School's arrangements for managing the access of providers to pupils of the School for the purpose of giving them information about the provider's education or training offer. This complies with the Trust's legal obligations under Section 42B of the Education Act 1997.

### Pupil Entitlement

All pupils in years 8-13 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events.
- To understand how to make applications for the full range of academic and technical courses.

Our provision includes various opportunities for students to gain access to a wide range of events. These are integrated into The Warren School's IAG programme and curriculum. The integrated events are usually delivered internally, with contribution from external providers where necessary. One off events, such as college open days and Careers Events are regularly advertised to our students, and where appropriate, visits will be arranged for groups of students to attend. The Warren School's policy on safeguarding sets out the School's approach to allowing providers into The Warren School as visitors to talk to the students. At all times we ensure that there are no risks or issues of safeguarding and that our students are always completely safe whilst meeting or speaking to external providers. ### **Opportunities for Access**

The school employs a careers advisor who works with students from all year groups with specific focus on Year 11 and Year 13 students to ensure they are able to make informed choices about their next steps. The advisor will meet identified targets in both Year 11 and Year 13 at least once, but where necessary repeat appointments can will be made.

The school also has a member of staff who works with students identified as at risk of NEET (Not in Education, Employment or Training). This staff member will inform students about the opportunities that other providers have, and provide guidance on making applications together for those selecting college or apprenticeship places.

The school also works closely with Connexions to ensure that suitable provision is provided and available to all students in their transitions into further education or work.
